"Something sparked," said Michael Meyer of the first time he visited St. John Center and met founding director Sister Kathleen Sheehan. That spark ignited a Meyer family legacy of caring that has endured for 17 years.

After many years of receiving gifts for Christmas and his birthday, both of which occur on Dec. 25, Michael asked his family to make a donation to SJC in lieu of giving him presents. As a result, three generations of Meyers and their friends spend all day and much of the night on Christmas Eve preparing to celebrate Christmas morning with St. John Center.

"It is a magical feeling," to be part of Christmas at St. John Center, Michael explained. "Everyone deserves a meal that tastes like it is prepared with love." In addition to serving a meal, the family also brings a variety of items the men can take with them to eat later. Michael is convinced that the tradition will continue because so many of the younger members of the family ask to be involved and are taking more and more responsibility for planning and executing the event.


"This opportunity has singularly redefined what Christmas means to

almost all of our family and closest friends. It is about the true meaning of giving," Michael said. Tina Link, Michael's sister, agrees. "We got into this because of Michael's passion, but it has become the highlight of our family's Christmas."

A legacy of caring

Chris Mueller was a 20-something when he started volunteering at St. John Center. In short order, he recruited his dad and cousins to join him. Now his daughters and nephews can be seen at SJC any given Saturday. The Mueller family's reach is beyond generations, too. Chris' cousin, Karen Oliver Morris, motivates

her Eastern High School students to collect hundreds of pairs of socks for the guys each October, now dubbed Socktoberfest.

Pat Peet's family is another example of a family with a strong commitment to St. John Center. "The Peet family doesn't celebrate Christmas until St. John Center celebrates Christmas," explains Pat Peet, "and all the children know it." They spend weeks gathering socks and scarves as well as coffee supplies for the shelter. They wrap gifts together and set a date to come share time with the guests. They consider it an honor to serve and believe the men give them greater gifts than what they can provide.

How does one family inspire a commitment to their neighbors? How does a family foster a giving spirit through generations? Whether part of an annual

tradition or weekly routine, the result of this spirit and commitment is a legacy of caring. With each gesture of love, St. John Center guests are drawn into the circle of support.

The fact that St. John Center opens our doors 365 days a year and continues to grow to meet the needs of people experiencing homelessness is a testament to what lives of gratitude and love for neighbor can enkindle. We are the tangible result of a legacy of caring in our community.
