### **Q: Why should I give to the St. John Center (SJC)?**

The St. John Center is a nonprofit organization committed to ending homelessness in our community. When you support St. John Center, you are ensuring that people who need it have a place of refuge and support along the path to housing and security.

### **Q: How can I be sure the SJC will use my gift wisely?**

SJC works hard to make sure your gift goes directly to efforts to help end homelessness.

### **Q: Is my gift tax deductible?**

Absolutely. The SJC is a 501(c)(3) organization and all monetary donations are tax-deductible to the fullest extent allowed by tax laws. Only exception are for raffle tickets and auction purchases.

### **Q: What is the St. John Center's tax ID number?**

Our EIN for tax purposes is 61-1135907.

### **Q: Is my online donation secure?**

Yes. SJC uses a secured server for online donations to protect your personal information.

### **Q: Does the SJC protect my privacy?**

St. John Center highly values our donors' privacy. We never sell, trade, rent or share our mailing list with anyone. Review our donor privacy policy.

We do not record the personal information of those who give "anonymously". This means you will not receive any communications from the SJC other than an automated credit card receipt.
